The Department of Toxic Substances Control (DTSC) invites you to review and comment on the Group 4 Resource Conservation Recovery Act Facility Investigation (Group 4 RFI) Sampling and Analysis Plan (SAP). The SAP describes the additional field investigation to be performed in the Group 4 reporting Area to complete the surficial media characterization. In response to DTSC's review and public comments received during the Group 4 RFI Report comment period in, DTSC is requiring additional sampling in the Group 4 Area, which encompasses the Coca, Delta, and Propellant Load Facility (PLF) RFI Sites of the Santa Susana Field Laboratory. These areas are located in southern portion of administrative Area II the Santa Susana Field Laboratory in the Simi Hills of Ventura County.
