



NOTICE OF PUBLIC COMMENT PERIOD

SANTA SUSANA FIELD LABORATORY GROUP 9 REMEDIAL INVESTIGATION REPORT SIMI HILLS, VENTURA COUNTY

The Department of Toxic Substances Control (DTSC) invites you to submit comments on the Santa Susana Field Laboratory (SSFL) Group 9 Remedial Investigation Report (Group 9 RI Report), previously referred to as the Group 9 Resource Conservation and Recovery Act Facility Investigation Report. The document name has changed under the statutory requirements of SB 990, which shifted SSFL regulatory oversight to Chapter 6.8 of the California Health and Safety Code.

This report summarizes the results of chemical investigations performed in the Group 9 Reporting Area at SSFL. Group 9 is located in a portion of Area II (owned by NASA) and portions of Area III, Area IV and the southern Undeveloped Area (owned by The Boeing Company). The Group 9 Reporting Area includes the Silvernale Reservoir, the Coca-Delta Fuel Farm, and the R-2a and R-2b ponds.
