NOTICE OF NON-COMPLIANCE - FORMER HUGHES MISSILE SYSTEMS COMPANY, 8433 FALLBROOK AVENUE, CANOGA PARK, CALIFORNIA (ORDER NO. 95-012, CI-7483)

Dear Mr. Samorano:

The California Regional Water Quality Control Board, Los Angeles Region (Regional Board), is the public agency with primary responsibility for the protection of ground and surface water quality for all beneficial uses within major portions of Los Angeles and Ventura Counties, including the referenced property above.

You are subject to Order No. 95-012, in which the Regional Board specifies waste discharge requirements for discharges from your remediation system. Under Monitoring and Reporting Program No. 7483, which is part of Order No. 95-012, you are required to self monitor your discharge and to submit monitoring reports at regular intervals.

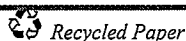
Non- Compliance with Waste Discharge Requirements

Staff had reviewed the monitoring reports submittal history from the 1st Quarter 1997 to the annual report of 2009. Staff found that during this period some of the quarterly and annual reports were not submitted on time as shown in the table below:

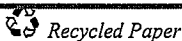
