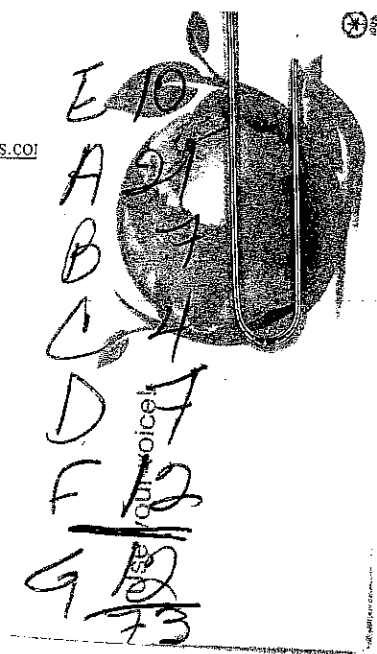

What is this petition for?

Chapter 6.8 of the Health and Safety Code provides for a CAG, a Community Advisory Group that consist of a broad cross-section of the affected community related to a cleanup action at the Santa Susana Field Laboratory [formerly known as Rocketdyne]. A Community Advisory Group provides to ensure that the public is informed and involved early; that their issues and concerns are heard; and that their comments are considered prior to final decisions by DTSC [Department of Toxic Substances Control] staff.

The cleanup of SSFL is based on two primary agreements signed by the responsible parties, [Consent Order 2007, Riley] by all the parties including NASA, DOE and The Boeing Company, and an Agreement on Consent (AOC) signed by NASA and DOE, with DTSC in 2010 which supersedes the other agreement to two of the three responsible parties.

Boeing Portion: Corrective action based on risk analysis as stipulated in the '07 Order.

NASA and DOE Portion: Cleanup to Background as defined by the recently completed Background Study conducted by US EPA [ARRA American Recovery Act funds]

Why do we feel it is needed?

Through Chapter 6.8 of the Health and Safety Code provides for a process that is open and balanced and includes all parts of the affected communities. We petitioned for a CAG because no public meetings on a community basis have occurred all year long despite the promised PPG process that community members spent over a year getting educated, learning about the various issues involved. Two years ago, DTSC denied our legally petitioned CAG and replaced it with a PPG (Public Participation Group) but those meetings stopped last year and we have had no public forum since. CAG is the only mechanism that is backed by statute where the agency CANNOT simply stop holding meetings, and must assist in getting the information/answers to the affected public.

We felt we needed an open process that is inclusive and cannot be shut down at the drop of a hat. DTSC has not been able to adequately "verify" the previous electronic CAG petition, in part, because of constraints within the "signon.org" electronic petition, we previously submitted in July.

We feel that narrowing the field of *who* should have a voice in this issue, would be a dis-service to the many people involved and interested in this site cleanup project. Considering the far-reaching impacts from nuclear and chemical remediation/cleanup actions, including disposal and remediation methods that meet the requirements of the agreements signed by each of the responsible parties.

In order to balance the cleanup with the impacts of the cleanup, as well as consideration to the future use of the site, we feel it is important to have a Community Advisory Group that is community driven, and gets answers to the many questions people have, and considers the many diverse opinions with regard to these matters. There are many who believe open-space is the best solution, and there is also great interest and concern about the native cultural impacts and the historic importance of the test stands where rockets were tested for the purpose of space technology and going to the moon. There are many who want to save some of the test stands for historical purposes. There is also a lot of real concern about the health impacts to local communities as the chemical and nuclear material released and discharged over the last fifty years is significant and much remains to be done. In Area IV alone (there are 4 areas, and Area 4 is the nuclear side), there are areas designated as "clearly contaminated" throughout Area IV with chemicals of concern, as well as radionuclides from the reactor programs that went on at the site starting in the fifties. Chemical impacts from rocket testing and laser technology exist on the other portions of the site that Boeing and NASA are responsible for and the facilities on the Boeing portions of the site have already been demolished.

Recently, a federal process began to "excess" the portion of the property that is owned by NASA (Area 2 and a small portion of Area 1) which also contains some of the most well-preserved Native Chumash Cave Paintings which need to be considered when we think of what will happen to the property in the future, and there is much interest from many, in how that is handled for the future--after cleanup, as well as decisions made during cleanup, that might otherwise affect those sacred areas.

Who is affected?

We feel that everyone interested is affected as there are a number of ways a person might feel affected and there is nothing in the statute that defines what "affected" means, however, the State is viewing this differently. Some people *care* because they live in the area, others care because they used to live in the area, or they are concerned about the open-space and preservation issues moving forward. Even though DTSC is viewing "affected" in a geographic sense, we feel it goes beyond that. But because the signatures are being disputed from the electronic petition which included people who live in other states who used to live in California, or were affected by the site in some other way. **We are therefore asking for signatures from residents *in the local area* on all sides of the site, for the purpose of petition submission and approval by DTSC, but will urge the CAG selection committee to**

please consider an inclusive format where all sides of the coin are heard and considered and included in the process.

Why does it matter?

It matters because none of these decisions can be undone, and have far-reaching affects for the current and future residents of the area. \$40 million in ARRA funds were used to investigate the nuclear portions of the site, but the other portions of the site have serious chemical impacts including serious impacts to the groundwater below from 500,000 gallons of TCE (a volatile organic solvent used to clean rocket engines among other things)

How it's cleaned up, matters. How we protect the history and the wildlife and sensitive eco-systems matters. Public Health Protection matters, considering the rising concerns about elevated cancers in the area. We need to figure this out and all interested stakeholders in the affected communities should have a voice and a place to go for reliable information.

What does it mean when you sign this?

The requirement is fifty signatures from people affected by the cleanup action, but the formation of the CAG is different. The state is required to assist us in formation of the CAG, and the selection process so an effective group representing these many views can collaborate and represent those concerns and questions throughout key decision points along the way. The signers of the petition are welcome to also submit an application as a CAG member, but this is **NOT** required and all CAG meetings would be open to the public. The purpose here is to hear the concerns from the public and communicate those to the decision makers and responsible parties who are then required to follow up and provide us with that information. This is the long-needed *back and forth* dialogue we have needed, instead of the one-way announcement format that has been controlled by a very small group for decades.

What will happen next?

Upon completing the petition, we will submit it to DTSC [Department of Toxic Substances Control] to the attention of Debbie Raphael, the department Director. After the DTSC assists us in formation of the CAG, the CAG will write its own procedures. DTSC will provide a place to meet, and funding can be attained from the responsible parties for facilitation needs should that be desired by the CAG and the affected public.

Who will receive this information?

In addition to Director Raphael, copies will be sent to Jim Marxen, DTSC Deputy Director of External Affairs, as well as the Secretary and Deputy Secretary of CalEPA [Matthew Rodriquez, and Miriam Ingenito] as well as a copy to the State Attorney General's office as well as the Governor's office.
